### Category "M" Products

SySTIUM® Technologies warrants that the Category "M" Products to be delivered hereunder, if properly used and installed, will be free from defects in material and workmanship and will substantially conform to SySTIUM® Technologies publicly available specifications for a period of three (3) years after the date the Product was purchased from SySTIUM® Technologies or a SySTIUM® authorized distributor.

SOFTWARE OF ANY KIND DELIVERED WITH OR AS PART OF PRODUCTS IS EXPRESSLY PROVIDED "AS IS" UNLESS SPECIFICALLY PROVIDED FOR OTHERWISE IN ANY SOFTWARE LICENSE ACCOMPANYING THE SOFTWARE.

If any Product furnished by SySTIUM® Technologies which is the subject of this Limited Warranty fails during the warranty period for reasons covered by this Limited Warranty, SySTIUM® Technologies, at its option, will:

- REPAIR the Product by means of hardware and/or software;
- REPLACE the Product with another Product,
- REFUND the then-current value of the Product if SySTIUM® Technologies is unable to repair or replace the Product.

If such Product is defective, transportation charges for the return of Product to Buyer within the continental USA will be paid by SySTIUM® Technologies. For all other locations, the warranty excludes all costs of shipping, customs clearance and other related charges.
